TERMS AND CONDITIONS FOR SUBMISSION OF A CONTRIBUTION

Please read the following Terms and Conditions carefully.

By submitting your blog and/or other content, you are agreeing to be bound by these Terms and Conditions.

Applicability Terms and Conditions

- 1. These Terms and Conditions apply at all times to to the submission of your blog and/or any other content including text, images, video's movies, plans, drawings, sketches etc. (hereinafter the "Contribution") to WDCD according to the invitation/open call published on the Site (url: http://whatdesigncando.com/blog-submission-guidelines) (hereinafter the "Invitation").
- 2. By submitting your Contribution, you agree to enter into a legally binding contract and/or legal commitment with Stichting What Design Can Do, residing in Amsterdam, The Netherlands (hereinafter WDCD) based on the following Terms and Conditions.
- 3. If you submit your Contribution you acknowledge, accept and confirm that you have had the possibility to read, have read and understand the Terms and Conditions, the fact that the Terms and Conditions apply to your relation with WDCD and you agree to be bound by the Terms and Conditions as well as any additional specific rules or agreements that apply to the submission of your Contribution.
- **4.** WDCD reserves the right to change any provisions of these Terms and Conditions, and any other terms, policy or guideline governing your use of the Site, at any time in its sole discretion. Such changes will be effective upon posting such revisions on the Site, and you waive any right to receive specific notice of such changes. You should frequently review these Terms and Conditions and any other applicable rules, policies, or guidelines on the Site.
- **5.** The applicability of any other terms or conditions is explicitly rejected.

WDCD invitation to submit your Contribution

6. WDCD maintains this Site as a platform for collaboration and a repository for innovative thoughts and ideas. On this Site, WDCD shall post some of the most pressing challenges we face around the world. Besides WDCD invites contributors with opinions, stories and innovative ideas to participate and collaborate in seeking solutions to these and other challenge(s) to submit blogs which will be published on the Site periodically.



7. Your Contribution to this Site, including any personally identifiable information, is entirely voluntary and non-confidential.

Submission, acceptance, publication

- **8.** You can submit your Contributions by sending it in a text file to the email address mentioned in the invitation.
- 9. Within a reasonable period after receipt of your Contribution by WDCD it will inform you whether WDCD declines or accepts the submitted Contribution according to its own discretion. WDCD is not obliged to inform you about the reason for declining your Contribution. It is not possible to object or oppose to such declination in any way whatsoever. Nevertheless, you can always submit a new Contribution.
- 10. If WDCD accepts your Contribution it is up to WDCD's to decide if, when or how the Contribution will be published. If your accepted Contribution needs editing WDCD will contact you to suggest the necessary edits. After mutual agreement between you and WDCD on the final form of the Contribution it is ready for publication by WDCD.
- **11.** When the Contribution is ready for publication and the date of publication is known, the agreed fee will be due to you by WDCD. The fee will then be paid to you within 14 days ultimately. To make the payment you shall provide WDCD with the necessary correct payment information.
- **12.** If WDCD decides to publish your Contribution the following credits will be used: By [your name], [date+year].

IP and Use of your Contribution

- 13. By submitting a contribution to WDCD, you automatically
 - a. represent and guarantee that you are the owner and or maker/author of the Contribution or, in instances where you have used someone's concept or work, that you are entitled and authorized to submit, reproduce, make available and publish the Contribution and any part thereof.
 - **b.** guarantee that your Contribution has not been published or made available to the public in any way whatsoever before submission to WDCD.
 - **c.** guarantee that the Contribution or parts thereof do not infringe upon any right of third parties.
 - **d.** inform WDCD which credits should be mentioned regarding sources or works of third parties used in/for the Contribution.
 - **e.** grant permission for your accepted Contribution to be posted on this Site as well as other related websites , via social media and through any other media;



- **f.** grant WDCD an unlimited, perpetual, irrevocable, assignable, royalty-free, fully paid-up license to use your accepted Contribution, in whole or in part, in any manner and through any media throughout the world, without further compensation than the agreed fee, notification, or permission, to you or any third party;
- **14.** You understand that WDCD has no obligation, either express or implied, to accept, develop, edit, use or publish your Contribution.
- **15.** Only after publication of your Contribution by WDCD you are entitled to publish your Contribution yourself or through a third party if accompanied by the following credits: "This blog has originally been published and made possible by What Design Can Do (www.whatdesigncando.com), [month+year]."
- **16.** You acknowledge that WDCD directly or indirectly, may be working on contributions similar to your Contribution, or already knows of such contribution from other sources. You also understand and acknowledge that other users may be working on the same or a similar contribution and you will not object to that.
- **17.** WDCD retains the right to at any time review, edit or delete from the Site any Contribution that WDCD at its sole discretion considers illegal, offensive, or otherwise inappropriate or contrary to the terms set out in the user conduct below.

User Conduct, liability

- **18.** If you submit your Contribution you shall not:
 - **a.** Post, use or transmit information or materials that you do not have the right to post or use, for example, under intellectual property, confidentiality, privacy, or other applicable laws.
 - **b.** Post, use or submit any confidential or proprietary information or materials otherwise subject to restrictions in use.
 - c. Post or transmit information or materials that are harmful, offensive, obscene, abusive, invasive of privacy, hateful or otherwise discriminatory, false, and misleading, incites an illegal act, or are otherwise in breach of your obligations to any person or contrary to any applicable laws and regulations.
 - **d.** Defame, abuse, harass, stalk, threaten or otherwise violate the legal rights (such as rights of privacy and publicity) of others.
 - e. Privacy

- **21.** WDCD does not wish to receive any confidential or proprietary information or materials otherwise subject to usage restrictions.

- **23.** You give WDCD permission to contact you regarding your submission, to send general mailings, specific information to participate and reminders concerning What Design Can Do and its activities and events.

General clauses

- **24.** WDCD may at any time:
 - (a) modify, suspend or terminate the operation of or access to this Site, or any portion of the Site for any reason;
 - (b) modify or change the Site, or any portion of the Site or related services, and any terms, conditions, additional terms and other policies governing the use of the site or services, for any reason;
 - (c) interrupt the operation of the site, or any portion thereof, for any reason, all as WDCD deems appropriate in its sole discretion.
- **25.** These General Terms and Conditions and the submission of your Contribution are governed by Dutch law exclusively. All disputes arising from the submission of your Contribution will be resolved by the competent court in Amsterdam, The Netherlands.
